"AN ACT REORGANIZING THE COMPOSITION OF THE BIDS AND AWARDS COMMITTEE (BAC) FOR THE MUNICIPALITY OF ANDA, PANGASINAN

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act (GPRA) which was approved in 2003 provides for the modernization, standardization, and regulation of the procurement activities of the government;

WHEREAS, this law is continuously being implemented for the sake of promoting good governance;

WHEREAS, the members of the Bids and Awards Committee (BAC) shall be designated in accordance with the guidelines provided for in RA 9184;

NOW, THEREFORE I, **JOGANIE RARANG**, *Municipal Mayor of Anda, Pangasinan*, by virtue of the powers vested in me by law, do hereby order;

Section 1. BAC COMPOSITION.

The membership of the BAC is hereby updated and shall be composed of the following:

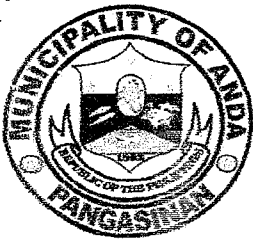

The BAC shall create a Technical Working Group (TWG) which shall be composed of a pool of Technical and / or financial experts. The members of the TWG shall be undertaken.

Section 2. Function of the BAC

- A: The BAC shall have the following functions:
1. Advertise and/or post invitations to bids;
 2. Conduct pre-procurement and pre-bid conferences;
 3. Determine the eligibility of the prospective bidders;
 4. Receive and open bids;
 5. Conduct the evaluation of bids;
 6. Undertake post-qualification proceedings;
 7. Resolve request for reconsideration;
 8. Recommend award of contracts to the Head of Procuring Entity (HOPE);
- B. In proper cases, the BAC shall also recommend the Head of the Procuring Entity to use Alternative Methods of Procurement;
- C. Conduct any of the alternative Methods of Procurement;
- D. Conduct periodic assessment of the procurement processes and procedures to streamline procurement activities pursuant to Section 3 of Revised Implementing Rules and Regulations of RA 9184;
- E. The BAC shall be responsible for ensuring that the Procuring Entity abides by the Standards set forth by RA 9184, as implemented by the implementing Rules and Regulations;

Section 3. Term of Membership

- A. Unless sooner removed for a cause, the member of the BAC shall have a fixed term of one (1) year from the date of appointment, renewable at the discretion of the Head of the Procuring Entity.
- B. In case of resignation, retirement, separation, transfer, re-assignment or removal, the replacement shall serve only for the unexpired term.
