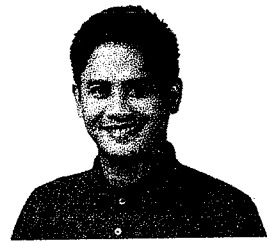

EXECUTIVE ORDER NO. 06

**“ORGANIZING THE PERSON WITH DISABILITY AFFAIRS (PDAO) OF THE MUNICIPALITY OF ANDA,
PANGASINAN”**

WHEREAS, Republic Act No 10070 otherwise known as an Act establishing Mechanism to ensure implementation of Program and Services for Persons with Disabilities in every province, City and Municipality, Amending Act No. 7277, otherwise known as the Magna Carta for Disabled Person, as Amended, and for Other Purposes, provides for the organization and establishment of Persons with Disability Affairs Office (PDAO) in every province, city, municipality;

WHEREAS, DILG Memorandum Circular 2010-103 dates 23 September 2010, provides the guidelines for the establishment of PDAO and designation of PWD Affairs Officers of Focal Persons;

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby organize the Persons with Disability Affairs Office (PDAO) of the Municipality of Anda, Pangasinan, as follows:

Section 1. PERSONS WITH DISABILITY AFFAIRS OFFICE (PDAO). The Head of PDAO or Focal Person is hereby designated in the person of Winie De la Cruz, President With Disability in Anda, Pangasinan.

Section 2. FUNCTIONS. The PDAO shall:

1. Formulate and implement policies, plans and programs for the promotion of the welfare of the PWDs in coordination with concerned national and local government agencies;
2. Coordinate the implementation of the provisions of RA 10070, Batas Pambansa BLG 344, otherwise known as the Accessibility Law, and other relevant laws at the local level;
3. Represent PWDs in meetings of the Municipal Development Council and other special bodies;
4. Recommend and enjoin the participation of Civil Society Organizations (e.g. NGOs, Pos, etc.) in the implementation of all disability related laws and policies;
5. Gather and compile relevant data on PWDs in the municipality;
6. Disseminate information including, but not limited to, programs and activities for PWDs, statistics on PWDs, including children with disability, and training and employment opportunities for PWDs;
7. Submit reports to the office of the Local Chief Executive (LCE) on the implementation of programs and services for the promotion of the welfare of PWDs in the municipality;
8. Ensure that policies, plans and programs for the promotion of the welfare of PWDs are funded both national and local government;
9. Monitor fund raising activities being conducted for the benefits of PWDs; and
10. Seek donations in cash or in kind from local or foreign donors to implement an approved work plan for PWDs, in accordance with the existing laws and regulations; and performs such other functions as may be necessary for the promotion and protection of the welfare of the PWDs.

Section 3. PDAO FUNDING. Pursuant to Section 4 of RA 10070, the Municipal Government shall ensure that the necessary find from any available local revenues is allocated for the implementation of PDAO activities for the benefit of PWDs in the municipality.

Section 4. SUPERVISION OVER PDAO OR FOCAL PERSON. The PDAO or Focal Person shall be lodged under the Office of the Local Chief Executive (LCE) As such, the LCE shall exercise supervision over the PDAO operations and activities.

Section 5. EFFECTIVITY. This executive Order shall take effect immediately.
