**“REORGANIZING/RECONSTITUTING THE MUNICIPAL TOURISM COUNCIL OF THE
MUNICIPALITY OF ANDA, PANGASINAN”**

WHEREAS, by virtue of the formulated Executive Legislative Agenda (ELA) for the Municipality of Anda, it was identified and stated that Tourism will be one of the developmental programs to be looked into by the Municipality to identify and develop its potentials;

WHEREAS, the Local Government Code encourage local governments to promote tourism in their respective jurisdiction;

WHEREAS, DILG memorandum Circular No. 95-162 dated October 1995 provides for the organization of Local Tourism Council to be composed of government and private sector representatives;

NOW THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby reorganize/reconstitute the Municipal Tourism Council of the Municipality of Anda, Pangasinan as follows:

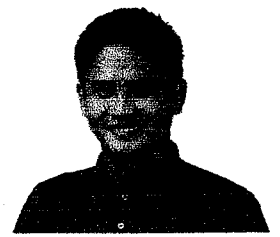
Section 1. Composition

Section 2. Functions.

The Municipal Tourism shall have the following functions:

- A. Prepare an annual plan on culture and the arts consonant to the Medium Term Philippine Development Plan for Culture and the Arts, to be integrated in the local development plan;
- B. Formulate programs and recommendation to develop local tourist destination, attractions and tourism facilities in the Municipality;
- C. Ensure the protection, preservation and conservation of the local culture and historical heritage;
- D. Conduct tourism and cultural events/ activities and programs in the Municipality;
- E. Conduct periodic consultations with the tourism stakeholders to identify concerns and formulate a solution;
- F. Encourage the development of Local Cultural industries;
- G. Coordinate with the Pangasinan Provincial Tourism & Cultural Affairs (PTCAO) and the Department of Tourism for assistance and support.

Section 3. Effectivity.

This Executive Order shall take effect immediately.
