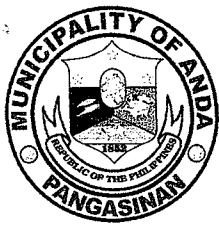
**“AN ORDER CREATING THE MUNICIPAL TASK FORCE FOR THE DEMOLITION
OF ALL CONSTRUCTED FISHPENS WITHIN THE MUNICIPAL WATERS OF ANDA,
PANGASINAN”**

WHEREAS, there is hereby created a Municipal Task Force to demolish all fishpens constructed within the territorial waters of Anda, Pangasinan;

NOW THEREFORE, I, JOGANIE C. RARANG, by virtue of the powers vested in me by law, do hereby order the Creation Task Force Executive Committee and Demolition Team of the Municipality of Anda with the following composition and tasks.

TEAM A – shall provide technical assistance and closely monitor activities during the demolition of fishpen.

TEAM B – shall provide the necessary equipment and needed facilities such as motor boats, bamboo raft and others.

TEAM C – shall be responsible for the order and safety of persons concern during the demolition.

SECTION 3. COMPOSITION OF THE SUPPORT COMMITTEE

MEDICAL COMMITTEE

CHAIRPERSON : **DR. GILLEN V. VUELTA**
MEMBER : **ALL RHU PERSONNEL**

COMMITTEE ON FOODS : **MAO STAFF**

The Medical Committee shall provide medical services to persons involve in the demolition activities.

The Committee on Foods shall provide food for all personnel involved in demolition activities.

SECTION 4. FUNDING – Operating expenses to be incurred in the implementation of the demolition activities on fishpens constructed within the Municipal Government of Anda, shall be charged on the accumulated balance from fishpen bonds booked under trust fund.

SECTION 5. COORDINATION – The Municipal Mayor or his authorized representative shall, for the proper implementation of the demolition activities, coordinate with the Provincial and National Government agencies concerned for guidance and possible assistance.

SECTION 6. SEPARABILITY CLAUSE – Any portion of our provision of this Executive order that may be declared unconstitutional or violation of existing national laws shall not have the effect of nullifying the other portions thereof; provided, that such remaining portion can still stand and be given effect in their entirety to accomplish the objective of this Executive Order.

SECTION 7. EFFECTIVITY – This Executive Order shall take effect immediately.
