“RECONSTITUTING THE MUNICIPAL HEALTH BOARD OF ANDA, PANGASINAN”

WHEREAS, Section 102 of Republic Act No. 7160 provide for a Local Health Board to established in every municipality;

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, by virtue of the power vested in me by law, do hereby reconstitute the Municipal Health Board of Anda, Pangasinan as follows:

SECTION 1. COMPOSITION

SECTION 2. FUNCTIONS

- A. To propose to the Sangguniang Bayan, in accordance with standards and criteria set by the Department of Health, annual budgetary allocations for the operation and maintenance of health facilities and services within the municipality;
- B. To serve as an advisory committee to the Sangguniang Bayan on health matters such as, but not limited to the necessity for, and application of local appropriations for public health purposes; and
- C. Consistent with the technical and administrative standards of the Department of Health, create committee which shall advise local health agencies on matters such as, but not limited to, personnel selection and promotion, bids and awards, grievance and complaints, personnel discipline, budget review, operations review and similar function.

SECTION 3. MEETINGS AND QUORUM

- A. The Municipal Health Board shall meet at least once a month or as often as may be necessary;
- B. A majority of the members of the Board shall constitute a quorum, but the Chairman or the Vice-Chairman must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of all the majority of the members shall be necessary to approve such proposals.


SECTION 4. COMPENSATION AND REMUNERATION

The Chairman, Vice-Chairman, and members of the Municipal Health Board shall perform their duties as such without compensation or remuneration. Members thereof who are not government officials or employees shall be entitled to necessary expenses and allowances chargeable against the funds of the Municipal Health Board, subject to existing accounting and auditing rules and regulations.

SECTION 5. EFFECTIVITY

This Municipal Executive Order shall take effect immediately.
