EXECUTIVE ORDER NO. 34

**“CREATING THE ROAD CLEARING AND DEVELOPMENT TASK FORCE OF THE
MUNICIPALITY OF ANDA, PANGASINAN”**

WHEREAS, President Rodrigo R. Duterte, during his 4th State of the Nation Address, directed all local government units to immediately clear roads and sidewalks nationwide of illegal structures and constructions, illegal vendors, and illegally parked vehicles;

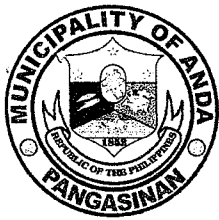
WHEREAS, the Department of the Interior and Local Government (DILG), pursuant to the aforesaid directive, issued on July 29, 2019, Memorandum Circular No. 2019-121 enjoining all local officials “to exercise their powers essential to reclaim public roads which are being for private ends and in the process, rid them of illegal structures and constructions”;

WHEREAS, the Memorandum Circular requires that “within sixty (60) days, significant results must be achieved, documented, and reported”, therefore strategic planning and immediate action must be undertaken;

NOW, THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CREATION AND COMPOSITION. The Municipality of Anda Road Clearing and Development Task Force is hereby created to be composed of the following:

SECTION 2. POWERS AND FUNCTIONS. The Task Force shall have the following functions and responsibilities:

1. Conduct consultation with concerned sectors and stakeholders on the implementation of the Memorandum Circular;
2. Formulate and implement strategies for the 60-day period on:
 - a. easing traffic and ensuring safety along public roads, alleys, and thoroughfares,
 - b. removing road obstructions and structures,
 - c. relocating public structures needing relocation;
3. Come up with a Road inventory, specifying existing obstructions and constructions, within LGU jurisdiction to be able to decide on roads and areas to be cleared and/or rehabilitated;
4. Submit weekly and quarterly reports to the DILG, monitor and evaluate the road clearing and development in the Municipality;
5. Recommend legislative measures, for sustainability, rehabilitation and development of roads and sidewalks, for adoption by the Sangguniang Bayan;
6. Rally the support of the Barangay Officials to act as advocates to sustain the efforts of the Task Force on road clearing and development, and the Municipality in general;
7. Perform such other functions consistent with or in pursuance of the above purposes.

SECTION 3. MONITORING TEAM. A Monitoring Team, composed of the following, shall validate the reports of accomplishments of the Task Force:

Specifically, the Monitoring Teams shall;

- a. Certify the compliance of LGU based on validated data
- b. Focus the monitoring on 1) road clearing vis-à-vis baseline, 2) strategy to address displacement, 3) sustainability mechanism, and 4) overall re: covered roads for public use as reflected in the flow of traffic and the ease of pedestrian.

SECTION 4. BUDGETARY ALLOCATION. Budgetary requirements for the task Force's operation shall be sourced from LGU fund.

SECTION 5. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately.
