**“REORGANIZING/RECONSTITUTING THE MUNICIPAL PRICE COORDINATING
COUNCIL OF THE MUNICIPALITY OF ANDA, PANGASINAN”**

WHEREAS, Republic Act No. 7851 as further amplified by DILG Memorandum Circular No. 2007-75 dated June 21, 2007, provides for the creation and activation of the Local Price Coordinating Council to monitor, convene and formulate policies and strategies to keep prices of basic consumer goods at reasonable levels;

NOW THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby order the reorganization/reconstruction of the Municipal Price Coordinating Council of the Municipality of Anda, Pangasinan as follows:

SECTION 1. COMPOSITION

The Municipal Price Coordinating Council of the Municipality of Anda, Pangasinan shall be composed of the following members:

SECTION 2. DUTIES AND FUNCTIONS

- A. Coordinate and rationalize the programs to stabilize prices and supply of member agencies in the municipality;
- B. Recommend to the NPCC or to the Implementing Agencies suggested retail prices (SRP) and/or the price ceilings for certain basic necessities and prime commodities in their respective areas;
- C. To conduct in-depth analysis on causes for price fluctuations;
- D. To recommend action steps to correct unwarranted prices increases and supply shortages;
- E. Develop and improved transport system.

SECTION 3. EFFECTIVITY

This Executive Order shall take effect immediately.
