**“AN ORDER CREATING THE COMMITTEE ON THE DISPOSAL OF
UNSERVICEABLE PROPERTIES OF THE MUNICIPAL GOVERNMENT OF
ANDA, PANGASINAN”**

WHEREAS, Article 435 of the Implementing Rules and Regulations of the Local Government Code of 1991 mandates the Local Government of Units that there shall be a Committee on Disposal of Unserviceable Properties which shall exercise exclusive jurisdiction in deciding the **Winning Bids of Awards** on the disposal of supplies and properties of the municipality;

WHEREAS, there are non-existing in various departments of the Local Government Unit of Anda considerable quantity of unserviceable equipment and property deteriorating and exposed to elements;

NOW THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, by virtue of the powers vested in me by law as the Local Chief Executive, do hereby order creating the Committee on the Disposal of Unserviceable Properties of the Municipal Government of Anda, Pangasinan.

In the expeditions disposal of unserviceable properties of the Local Government Units, process provides;

SECTION 1. DISPOSAL COMMITTEE

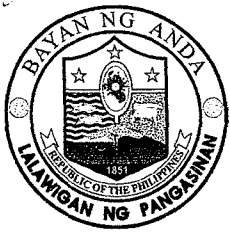

SECTION 2. DUTIES AND FUNCTIONS

1. Inspect the unserviceable properties to verify justification for disposal;
2. Set the final appraised value of all disposable property considering obsolescence, market demand, physical condition and result of previous biddings for similar property;
3. Recommend the Local Chief Executive for approval and the manner of disposal;
4. Ensure that proceedings conducted are in accordance with the existing laws and regulations;
5. Perform such other functions as may be desirable, necessary and analogous to the foregoing duties and functions.

SECTION 3. MODES OF DISPOSAL

1. Sale thru public bidding. Sale shall be published in newspaper and/or the website of the municipality and disclosure boards;
2. Should the sale thru public bidding be unsuccessful, the Committee may be dispose the property at any manner deemed cost advantageous to the government, including thru barter or negotiated sale at not less that the Committee appraised value;
3. Barter with other government agencies and government owned or controlled corporation.

SECTION 4. Dropping from the books of accounts of disposed property shall be subject to existing accounting and auditing rules and regulations.

SECTION 5. EFFECTIVITY

This order shall take effect immediately.
