EXECUTIVE ORDER NO. 42
Series of 2019

**AN ORDER DECLARING "NO PLASTIC POLICY" EVERY MONDAY DURING MARKET DAY
IN POBLACION, ANDA, PANGASINAN**

WHEREAS, RA 9003 is a primary legislation on solid waste management providing a comprehensive, systematic and ecologically viable program that would:

- Ensure public health and protect the environment
- Employ environmentally – sound methods to encourage resource construction and recovery and promote national research and development programs.
- Encourage greater private sector participation while retaining the primary enforcement and responsibility of solid waste management with local government units.
- Integrate the ecological SWM and research conservation and recovery topics into the academic circular of formal and non-formal education.

WHEREAS, residential waste constitute the single largest source of waste generated in urban areas, followed by street garbage and market wastes;

WHEREAS, the production of chlorofluorocarbons (CFCs) used in industry such as Styrofoam, hair sprays, plastics, solvents in refrigeration and air conditioning eats up the ozone layer in the atmosphere loosening the protective covering of the earth from destructive solar radiation;

WHEREAS, these plastic, styrofoam, hair sprays and others when indiscriminately thrown alongside streets and thoroughfares are main contributors that clogged canals and impede the flow of the water going to downstream area;

WHEREAS, market goers are encouraged to bring their own bag for any merchandize they bought or any of the recommended containers as follows:

1. Woven (Bamboo) Basket – fruits and vegetables, root crops, coco extract, spices, agri-products, can goods, noodles, etc;
2. Sako (Bayong) Bag – fresh meat, chicken, fish, frozen foods, sea shells, sea weeds, etc. (wrap in single plastic);
3. Paper Bag/Box - native cakes; such as bibingka, puto, sapin-sapin, suman (wrap in banana leaves) cakes, pastries, bread, noodles, etc;
4. Buri Bag – cooking oil, vinegar, canned goods, salted fish (in bottle or sachet);
5. Sack (Bayong) – feeds, rice trigo and flour.

WHEREAS, any individual or persons' complying to this order shall be given incentive upon recommendation of the monitoring team of the market monitoring team of Anda;

NOW THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of Anda, Pangasinan, by virtue of the powers and authorities vested in me by law as the Local Chief Executive, do hereby order declaring **"NO PLASTIC POLICY"** every Monday within the territorial jurisdiction of the Municipality of Anda, Pangasinan.

EFFECTIVITY: This Executive Order shall take effect immediately upon signing hereof, shall remain in full force and effect unless revoked in writing by the undersigned.
