EXECUTIVE ORDER NO. 45
Series of 2019

“DESIGNATING A FOCAL PERSON ON ENVIRONMENT AND NATURAL RESOURCES/SOLID WASTE MANAGEMENT IN THE MUNICIPALITY OF ANDA, PANGASINAN”

WHEREAS, Section 12 under Article 1 of Republic Act No. 9003 provides for the creation of Municipal Solid Waste Management Board that shall prepare, submit and implement plan for the safe and sanitary management of solid waste generated in areas its geographical and political coverage;

WHEREAS, the increasing volume of garbage is posing a serious threat to the general welfare and health of the people, as well as to the integrity of the environment;

WHEREAS, this health and environment problem requires utmost attention and cooperation among the concerned national government agencies, local government units, business community, civil society and the people in the general;

NOW THEREFORE, I, JOGANIE C. RARANG, Municipal Mayor of the Municipality of Anda, Pangasinan, by virtue of the powers vested in me by law, do hereby designate **MR. MAC ARTHUR F. ASEO** as **Focal Person on Environment and Natural Resources/ Solid Waste Management of the Municipality of Anda, Pangasinan**.

MR. MAC ARTHUR F. ASEO shall perform the following functions:

1. Formulate measures for the consideration of the sanggunian and provide technical assistance and support to the mayor in carrying out measures to ensure the delivery of basic services and provision of adequate facilities relative to environment and natural resources;
2. Record all issued mayor's permit fish cages by the Chief Executive, and list of operators and numbers of fish cages in a separate control record book;
3. Closely monitor the proper management and operation of the aquaculture industry of the municipality particularly on the following:
 - a. Designated area allowed for fish cage operations;
 - b. Allowable volume of stocking per cages;
4. Develop plans and strategies and upon approval thereof by the mayor, implement the same, projects which the mayor is empowered to implement;
5. Counter check and signed all applications of fish cages operation and Hotel, Inn, Apartments and Resort operation;
6. Provide extra extension services to beneficiaries of forest development projects and render assistance for natural resources-related conservation and utilization activities consistent with ecological balance;
7. In charged with the proper management and operation of the Anda Sanitary Landfill;
8. Coordinate with the government agencies and non-government organizations in the implementations of measure to prevent and control land, air, and water pollution with the assistance of the Department and Natural Resources;

9. Exercise and supervise the proper disposals of solid waste, grey or waste water and hazardous waste from their source of origin to the Anda Sanitary Landfill;
10. Be in the frontline of the delivery of services concerning the environment and natural resources, particularly in the renewal and rehabilitation of the environment during and in the aftermath of man-made and natural calamities and disasters;
11. Recommend to the sanggunian and advice the mayor on all matters relative to the protection, conservation, maximum utilization, application and appropriate technology and the matters relate to the environment and natural resources;
12. Submit an updated and development report to the Local Chief Executive and at the Office of the Oversight Committee of the Sangguniang Bayan every first Tuesday every quarter. However, in case the first Tuesday of every quarter coincides with any holidays the next office day may appropriate and or from time as maybe required.
13. Exercise such powers and perform such other duties and functions as may be prescribed by law or ordinance.

This Executive Order shall take effect immediately.
