**EXECUTIVE ORDER NO. 46**  
**Series of 2019**

**“AN ORDER CREATING THE MUNICIPAL TASK FORCE TO  
END LOCAL COMMUNIST ARMED CONFLICT, AND  
DIRECTING THE ADOPTION OF A PEACE FRAMEWORK”**

**WHEREAS**, Article II of the 1987 Constitution provides for the following State principles and polices;

- i. The Philippines renounces was an instrument of national policy;
- ii. The maintenance of peace and order, the protection of line, liberty, and puberty, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy; and
- iii. The state shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services promotes full employment, a rising standard of living, and on improved of life for all.

**WHEREAS**, Executive Order No. 70 (s 2018) institutionalized the Whole-of-Nation in attaining inclusive and sustainable peace, which calls for the end all armed threats in the Philippines and recognized that internal socio-political stability rest upon healing the rifts that divide the nation by promoting participatory governance, synergy of government development efforts, and enhancing the participation and responsibilities of Local Government Units (LGUs);

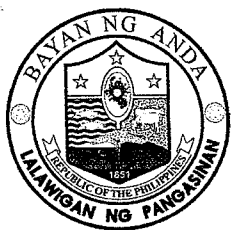
**WHEREAS**, the Whole-of-Nation approach addresses the root causes of insurgencies, internal disturbance and tensions, and other armed conflicts and threats by prioritized and harmonizing the delivery of basic services and social development packages by the government, facilitating societal inclusivity, and insuring active participation of all sector of the society in the pursuit of the country's peace agenda;

**WHEREAS**, there is a need to create a task force that will provide an efficient mechanism and structure for the implementation of the Whole-of-Nation approach to aid in the realization of the collective aspiration of the Filipino people to attain inclusive and sustainable peace and order at the local level;

**NOW THEREFORE, I, JOGANIE C. RARANG**, Municipal Mayor of Anda by virtue of the powers vested in me by law do hereby order the creation of MTF-ELCAC

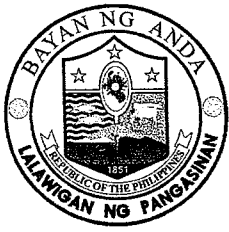

**Section 2. Duties and Responsibilities of the MTF-ELCAC**

1. Ensure the creation of Barangay Task Force which shall complement E.O No. 70 within their areas of jurisdiction;
2. Take lead in the planning and implementation of the Retooled Community Support Program (RCSP);
3. Enlist the assistance of any department, bureau, office, agency, or instrumentality of the government, the government-owned or controlled corporation (GOCCs), and state universities and colleges (SUCs), in accordance with their respective mandates, in coordination with the PTF, in the implementation of the RCSP;
4. Facilitate the convergence of all stakeholders and ensure participation of the community members in development planning;
5. Adhere to the feedback mechanism prescribed by the Provincial Task Force and establish the same at the Municipal down to the Barangay level;
6. Ensure the delivery of services and inclusion of the policies, programs, projects, services, and activities in the local plans based on the identified solutions by the members of the affected communities;
7. Strengthen and empower Barangay-Based Institution (BBIs);
8. Establishment and strengthen citizenship and community participation mechanism to guarantee sustainability of RCSP implementation;
9. Perform such other duties and functions as the Regional or the Provincial Task Force may direct .

**Section 3. The Peace Framework**

The Peace Framework shall contain principles, policies, plans and programs that will bring the inclusive and sustainable peace and address the root cause of insurgencies, internal disturbances and tensions as well as other armed conflict and threats in identified areas. The peace framework shall be responsive to local needs and sensitive to realities on the ground. To this end, the Peace Framework shall include a mechanism for localized peace engagement or negotiations and interventions that is nationally orchestrated, directed and supervised while being locally implemented.

**Section 4. Convergence**

All departments, bureaus, offices, or instrumentalities of government, including schools, are hereby directed to render the necessary support to the MTF-ELCAC.

**Section 5. Secretariat and Its Duties and Responsibilities**

The MTF-ELCAC shall be assisted by the joint Municipal Peace and Order Council (MPOC) and Municipal Development Council (MDC) Secretaries to be led by the POC Secretariat duly assisted by the personnel from the members-department/agencies of the MTF-ELCAC under secondment, detail, or other appropriate arrangement.

The following are the duties and responsibilities of the Secretariat:

1. Submit and organization and staffing pattern and directory of the MTF-ELCAC to the Provincial MTF-ELCA within one(1) month from its creation;
2. Provides standard secretariat to the MTF-ELCAC;
3. Ensure proper coordination of the RCSP implementation through the feedback established by the Provincial MTF-ELCAC;
4. Ensure that all policies, plans, and programs, formulated by the MTF-ELCAC are carefully carried out; and
5. Perform such other functions as maybe directed by the MTF-ELCAC.

**Section 6. Monitoring and Submission of Reports**

The municipal mayor as Chairman shall ensure that the submission of regular Quarterly Accomplishment Reports to the Provincial MTF-ELCAC, through the Secretariat.

**Section 7. Funding**

The budgetary requirements for the implementation of this program shall be chargeable to LGU fund and shall be included in the Municipal Peace and Order and Public Safety Plan subject to the usual auditing requirements and other pertinent laws, rules and regulations.

**Section 8. Effectivity**

This Executive Order shall take effect immediately.
